Please include in your entry **references** pertaining to the candidate's work with the five most relevant articles to the entry clearly marked, as well as up to **three supporting letters** by people not directly affiliated with the candidate research group/s (The complete bibliography should include at least 5 publications/communications since 2017).

Please submit by mail all material typed in English, both on paper and disk/digital form (Microsoft word or adobe.pdf format). If letters are sent separately please make sure they identify the entry and are also sent both in paper and digital form (email/thumb-drive).
